I have attended meetings as President virtually to discuss the work of the CCPA and Chapters. I feel very fortunate to be able to represent the Manitoba and Nunavut members on the National Board of Directors and to be the Board Liaison for the Manitoba Chapter. I have had this privileged since 2018 and will complete my term May 2023. It has been exciting to see both our organization of CCPA grow beyond +10,000 members and the Manitoba Chapter flourish in launching many new initiatives and expanded membership.

As you will hear throughout their reports today, the dedication and energy of the Manitoba Chapter can be heard in the progress made towards regulation on FACT-MB, Continuing Education opportunities, and in working towards Truth and Reconciliation. I want to thank the Manitoba Chapter Board and committee members for their endless work, commitment, and high level of professionalism.

In my role as a member of the CCPA National Board of Directors, our responsibilities are to ensure the policies, procedures, initiatives, and advocacy work of the Association are aligned with the best interests of our members and the public. The board meets monthly via zoom. In addition to these board meetings, there are several standing committees of the board. I am Chair of the Awards Committee and sit on the Advancement for Clinical Supervision (ASC) Committee. I am also part of a sub-committee working on creating new opportunities and resources to aid the development of clinical supervisors. Very exciting to be part of this ground-breaking work.

The Manitoba and Nunavut Region membership continues to grow with 508 members as of April 2022. The growth has been in both professional and student memberships. However, the greatest increase is in student membership. With currently 90 students, this is a 61% increase over last May's 56 student members. Part of my role as Regional Director is supporting the CCPA Student Reps and connecting with each of our province's universities.

The CCPA 2022 Conference is coming up quickly - May 19 -22, 2022. Originally planned to be in-person in P.E.I. the impact of the ongoing pandemic made everyone pivot again this year. Not to worry. The full slate of pre-conference and conference workshops are all virtual. Hope everyone can take advantage of this wonderful opportunity to connect with each other and grow in our professional knowledge.

Hopefully everyone got an opportunity to celebrate in some way in April, CCPA's Inaugural Counselling and Psychotherapy Month. In addition to a number of activities and offerings to members, National office hosted 12 different events over the month. All free of charge for members. In addition to these events, (CCPA) held a virtual Parliament Hill campaign from April 25-27 2022 to raise awareness of our recommendations to improve access to counselling/counselling therapy/psychotherapy services. CCPA spokespersons from the Board of Directors, National Office staff, and Chapter Boards/Executives met with Members of Parliament to raise the profile of the profession and advocate on our recommendation. Two issues are in having counselling/psychotherapy GST exempt and in re-instating CCCs in the NIHB program. I have included links to both position papers below

## FACT MB Report for CCPA Manitoba Chapter Annual General Meeting

## May 15, 2022

- 1. The Regulated Health Professions Act (RHPA) process progressing. The initial stage of public consultation "to allow organizations with interest and expertise, including therapy and counselling services, health organizations, affected regulatory Colleges, etc. time to respond and provide their valuable contribution to The Health Professions Advisory Council (HPAC)'s public consultation" concluded February 28, 2022. HPAC is established under the RHPA and is responsible for advising the Minister of Health on matters relating to the RHPA and the regulation of health professions under the RHPA to determine if it is in the public interest to regulate Counselling Therapy as a health profession under the RHPA. FACT-MB has been informed that HPAC is adding two more members to their committee to work towards regulation in Manitoba.
- 2. On April 19, 2022, the HPAC invited participants to participate in the second phase of consultation with all individuals and organizations that provided an initial written response to HPAC commenting on the regulation of the Counselling Therapy profession in general and on the completed application from the Federation of Associations of Counselling Therapists of Manitoba (FACT Manitoba) for self-regulation of Counselling Therapy under The Regulated Health Professions Act (RHPA). The second phase provides all consultation participants with an opportunity to electronically access and view a copy of all written submissions from other participants and to provide a written response with any additional comments by May 31, 2022. A sub committee was struck to work with Barb MacCallum to respond to the concerns. - 3. FACT-MB has made a decision to reach out to the Indigenous leaders, i.e., MKO, MMF, Southern Chiefs, Tribal Councils for consultation in the regulation process with respect to their interest, leadership structures and traditions with a formal letter.
- 4. CRPO (Ontario) hosted a fourth pan-Canadian regulatory meeting online in April, which was attended by Don Russell and Ellie Jack. They were updated on the recent advances on regulation in the unregulated provinces across Canada.
- 5. CCPA National launched the Inaugural Annual Counselling and Psychotherapy Month with the intention of promoting the profession of counselling/ psychotherapy in Canada every year in April. They invited all the member associations of FACT-MB to participate.
